Re: METERING-PANELS PTY LTD PRODUCT RANGE

I am please to advise the Victorian electricity distribution companies have no objection to the use within Victoria of the Metering-Panels Pty Ltd pre-wired meter panel product range using 600 H x 600 W and 900 H x 600 W meter panels as examined by their representatives in May 2016 provided they meet the conditions described below.

Your VESI Acceptance Number is SIR140616B. This number must be included with your catalogue number and marked on each individual meter panel as follows:

- 600 H x 600 W – maximum of six single phase meters; and
- 900 H x 600 W – maximum of nine single phase meters.

The catalogue numbers accepted are: MP-6W+HWS; MP-6W+ISO+HWS; MP-6W+ISO; MP-6W; MP-9W+HWS; MP-9W+ISO+HWS; MP-9W+ISO; and MP-9W.

The Victorian Service & Installation Rules Management Committee on behalf of Victorian electricity distribution companies AusNet Services, Citipower, Jemena, Powercor Australia, and United Energy Distribution provides this acceptance. This acceptance is based upon:

- The meter panels suitability as installed on the metering frames for the Metering-Panels Pty Ltd product range. It does not infer the meter panels and the Metering-Panels product range are compliant with the Victorian electricity safety regulations or any other regulations; and
- The metering equipment layouts for the 600 H x 600 W and the 900 H x 600 W meter panels aligns with that as presented to the VESI Service & Installation Rules Management Committee.

The formal acceptance and the VESI Acceptance Number are for the meter panels installed on the Metering-Panels Pty Ltd product range of metering frames as presented and in accordance with the documentation you have supplied. The VESI Acceptance Number must not be placed upon any modified or different meter panels without the consent of the committee.
